 - i. Responsibilities: The Conductor should have past conducting experience as well as be knowledgeable in music /rehearsing techniques including general flute techniques. The Conductor will receive music from the Artistic Director and prepare music for rehearsals and performances. The conductor will be present for all rehearsals and performances. In the event of absence, the Conductor is responsible for securing a substitute. The Conductor will assist in selecting music for various competitions (i.e. Texas Flute Society, National Flute Association).
 - ii. Selection: The ensemble will select a new conductor as the position becomes available using "Music Director Selection Survey" and algorithm program.
